- o Asphalt milling will begin April 25th. (3-4 days)
- Paving is scheduled to begin April 28th. Paving will create traffic delays up to 15 minutes at the side street intersections, while paving through each intersection. Paving should take approximately 4 days to complete.
- The road crew will work from 8:30AM to 4:30PM.

- Cedar Fence Budget: Currently at 160% of plan, due to increasing costs on timber posts and removal efforts, ~60 posts completed at this time
