  - Paint the exterior Farmhouse window trim

### **Treasurer's Report – Steve King**

- Board members were shared a draft copy of the 2024 Budget for their review and comments. Final modifications will be completed by month end.
- Income YTD is at 99.2%, well done by the HOA Mgmt team to collect on dues and leases.

- Administration: 97% of budget, insurance costs and blanket policy slightly more than planned
- Farmhouse Expenses: 91% of plan for the year
- Pumphouse: 158% of plan due to calendar year, which includes an extra payment from 2022 being made this year.
- The CPI index will be used to increase SVHOA water lease bills.
- Landscape: 100% of plan but will be over budget due to calendar year 2022 payment being made in 2023.
- Pool and Tennis: 8-% of plan, pool contractor fees were slightly less this year than last.
- Utilities: 92% of budget, 2024 budget raised slightly to accommodate expected increases.
