Neighborhood Manager's Report

- Accounts Receivable There were 3 homeowners past due over 90 days. 11 homeowners were 30 days + past due.
- Farmhouse carpet Additional samples were reviewed by the board. The estimate for these sample is \$2800 installed.
- Pool monitor interviews are being conducted. 5 candidates applied for 3 openings.
- Garage sale the board agreed to have community garage sale on Saturday, June 25th, the day prior to the Community Party.
- Neighborhood party is scheduled for Sunday June 26th at the Farmhouse pool and common area. The activities will include:

President's Report – Tom Wicher

• Farmhouse Roof – Significant wear requires that we consider shingle replacement. One bid has the Satellite Pool house at \$2000 and Farmhouse at \$21,600. Additional bids will be gathered.

• Pool Furniture Storage: Pool furniture and pool covers are currently stored at Access Storage and are transported there each spring and fall. Since the current maintenance contractor is retiring, we are considering adding onsite storage, to reduce transporting and storage expense.

A free-standing storage shed at the Satellite Pool and possibly an enclosure at the Farmhouse are being considered. The board agreed to get bids for the Satellite Pool storage building.

Treasurer's Report – Steve King

- Income-45% of plan, no issues
- Expenses:
 - Admin: 30% of plan, postage at 70% due to envelope purchase, may explore a more cost-effective options if HO emails database update is successful
 - Farmhouse: 24% of plan,
 - Landscape: 30% of plan,
 - Cedar fence post replacement expenditures are completed until fall, 60 posts were replaced, more are needed this fall

Landscape Updates – Steve King

- 14 irrigation system issues caused by the ACHD curb work were identified by Hopkins. SV and Hopkins personnel met with Avalon (ACHD's contractor) to make the repairs. Hopkins will repair the control wiring issues.
- Blue Ribbon is conducting a tree survey; they will be mapping all trees in all areas to assess the health, size and safety.
- A bid was accepted for trimming the Locust Tree overhanging the tennis courts. The work is pending.
